VEHICLE APPEALS MUST BE FILED WITH THE FORSYTH COUNTY TAX COMMISSIONERS OFFICE IN ACCORDANCE WITH THE PRECEDING PARAGRAPHS, AND CONTAIN ALL THE NECESSARY INFORMATION IN ORDER FOR THE BOARD OF TAX ASSESSORS TO REVIEW AND APPROVE THE VALUATION. FAILURE TO FILE AN APPEAL IN ACCORDANCE WITH THE ABOVE WILL RESULT IN THE LOSS OF APPEAL RIGHTS.
